At the same time, was instrumental in restructuring the laboratory's environmental cleanup plans to reduce the completion schedule by 35 years and reduce the life cycle projected cost by \$19 Billion. Achieved three significant environmental regulatory milestones and maintained good relations with the State of Idaho and the Environmental Protection Agency.

November 1995-February 2003**Deputy Manager: U.S. Department of Energy, Idaho Operations Office**

Led National Laboratory in ensuring appropriate balance between research and development and the required environmental clean up of the site to ensure a future growth of the laboratory. Met 455 of 458 environmental regulatory milestones. Served as acting Manager several times including from February 1999 to June 1999. Led transition between outgoing and incoming operating contractors. Obtained and held two Nuclear Regulatory Commission licenses for independent spent fuel storage installations. Was lead DOE representative in resolving disputes with environmental regulatory agencies. Drove size of Operations Office staff down from over 425 to less than 325 using attrition. Led in the integration of the Grand Junction Office into the Idaho Operations office. Served as ex officio member of Board of Directors of the Eastern Idaho Economic Development Council. Served on team that advised the Under Secretary of Energy on regulation on Department nuclear activities.

May 1983-November 1995**Chief Counsel: U.S. Department of Energy, Savannah River Operations Office**

Represented the Department in numerous major lawsuits with environmental organizations, the state of South Carolina and contractors. Was successful in prosecuting a major unallowable cost action against incumbent operating contractor. Led the site in the transformation from reliance on a single operating contractor for over 40 years to first, transitioning to a major security contractor, and second, transitioning to another operating contractor that entailed creating from scratch all major business and operating systems for the site. Served as key advisor to the Manager. Also served on Department teams that applied the Resource Conservation and Recovery Act requirements to Department activities and recommended to the Secretary of Energy the technology for the next generation of uranium enrichment.

August 1976-May 1983**Attorney-Adviser: U. S. Department of Energy and Energy Research and Development Administration**

Represented the Department and Naval Reactors in contested Nuclear Regulatory Commission proceedings including obtaining a construction permit for the Clinch River Breeder Reactor. Was the lead attorney in sensitive negotiations with the state of New York regarding the West Valley Demonstration Project. Was instrumental in drafting and ensuring enactment of legislation such as the Nuclear Waste Policy Act of 1983, the West Valley Demonstration Project Act and the Low Level Radioactive Waste Policy Act. Represented the Department in numerous lawsuits. Served as chief legal advisor to the Assistant Secretary for Nuclear Energy and the Assistant Secretary for Defense programs on radioactive waste matters.
